**BUDGET REPORT / FINANCE ISSUES AND CONCERNS:** Finance Officer Lindsey provided the Financial Report for February 28, 2024, included with these Minutes, and the following additional information:

- EBingo machines: Collected \$16,491, paid out \$16,404, for a profit of \$86.30, including February 1 through 27.
- Fish Frys doing well, despite the snow on the first night.
- The new Point of Sale accounting system will arrive tomorrow, and be operational at this week's Fish Fry.

# **OPEN ISSUES / OLD BUSINESS:**

• Carey described revisions to Post Constitution and By Laws requested by Dept. of Ohio, which were distributed by email to the EC February 7, and recommended submitting them to the membership for adoption at the general meeting March 13.

Motion (Carey) made to approve submitting the revised Constitution and By-Laws to the membership for adoption at the general membership meeting March 13, 2024, was Seconded (Wolfangel) and approved unanimously.

- Wolfangel reported on the CLUB ROOM POLICY PROPOSALS, as follows:
  - Following discussion at 1/31/24 E.C. Meeting of a proposed Club Room Utilization Policy, and a proposed new Honor Bar and Guests Policy, E.C. suggested that consideration be given to attempting to merge the two policies into one policy, since they both generally dealt with the Club Room Utilization.
  - Kirk Minnich and I have constructed a merged proposed policy which was sent to all E.C. members and 3 SAL officer, with E.C. Meeting Reminder Notice, for review and any discussion or adoption at this E.C. Meeting.

Motion (Wolfangel) made to adopt the revised version of the Club Room Utilization Policy and Honor Bar and Guest Policy was Seconded (Lindsey) and unanimously approved.

- Wolfangel reported on the DESIGNATION OF HALL "B" IN MEMORY OF DON BISHOP, as follows:
  - All items and photo groups, relative to the reflection on, and recognition of, Don Bishop are now in place on exterior wall of Hall "B".
  - A marble plaque similar to the Post's brass plate designating Hall "B" in recognition of Bishop was provided by former A/T Trustee Andrew Pappas, and has been installed above door on interior wall of Hall "B".

#### **NEW ISSUES / NEW BUSINESS (Polling of Committee Chairs):**

Minnich reported the Marketing Committee reviewed the alcoholic beverage pricing list, and did not make any changes.

Membership: Chair Kamman reported:

- Our goal is 177, and we are now at 171, with a couple more new prospective members.
- A member orientation class is being developed, including SAL.
- National is raising their dues by \$5 next year, so the Post dues needs to be raised to \$45 next year. The Department of Ohio will likely also increase their dues by \$5 in the next year or so.

Motion (Kamman) made to increase the Post dues from \$40 to \$45 next year was Seconded (Wolfangel) and approved unanimously.

- He encouraged members to renew for 3 years now at \$120 to avoid the dues increases during that time.
- Caskey is compiling a binder with all the PUFL and Life member certificates that can be found.

- 2. AARP has begun having tax help in Hall A 2/5/24 to 4/15/24 Monday thru Friday
- 3. The East Side Republican Club (ESRC) is renting Hall B, typically the last Tuesday of each month in 2024 (with a few exceptions)
- 4. The Warbirds are renting Hall A, typically the first Monday of each month starting in February (with a few exception). They will not be having a bartender but will be using the Club room for drinks.
- 5. All my rental dates, times and locations that I have booked so far for 2024 are on the Post calendar
- 6. Hall account: balance as of 2/26/24 is \$3,154.00
- 7. I had surgery for tears in my Achilles tendon on 1/25/24 and have very limited mobility until mid-March

Kamman reported the bar pendant lights have been removed, and the LED can lights above the bar have been connected to the dimmer switch.

#### **Uniform Ceremonies**: Caskey provided the following report:

members (Bishop vacancy and two expanded Board vacancies).
