NEW ISSUES / NEW BUSINESS (Polling of Committee Chairs):

Membership: Chair Kamman reported:

- We are at 156 of 177 (88%) members renewed, which is behind our usual progress at this date.
- 25 existing members not yet paid, 4 of which did not renew last year.
- He and Wolfangel continue working on having an orientation for Post and Squadron new members.

Chaplain/VAVS:

No report, as VAVS is not operating at this time.

Americanism: Chair Howland provided the following report:

- Currently searching for BBS and BGS participants. Interest forms deadline is February 1; interviews of applicants are planned for early February. Expecting entries from AHS, but no response yet from THS. BGS requires \$50 nonrefundable deposit with each commitment, but BBS does not. *Motion (Lindsey) made to cover the \$50 deposit from Post funds, to be reimbursed by Charities, Inc. if CI funds are available, Seconded (Alfieri) and approved unanimously.*
- All other factors being equal among contestants, scholarships from the Post favors those participants sponsored by a Post member; however, no contestant has been denied a scholarship to date. The Post allots \$3,000 total for the scholarships. Each scholarship will be likely be between \$500 and \$1,000.
- Posting applications to the website is not working. Minnich is taking over the website operation from Richardson, and Kamman is working with Richardson learning the formatting system.

Community Support & Recognition: (Vacant)

In his excused absence, Bishop submitted the following:

"<u>Hillcrest Cemetery</u>: Anderson Township has decided to take over ownership of Hillcrest Cemetery. Their primary role will be to assume responsibility for cemetery maintenance. The Coalition to Save Hillcrest will continue to make necessary infrastructure improvements, and repairs to the cemetery.

<u>Collaborative Art Projects:</u> While searching for resource to complete an art project at Hillcrest Cemetery, I was introduced to two women who are pulling together Collaborative art projects within the community. I am meeting with them soon to discuss Hillcrest, but I also know that they would like to meet with the EC to discuss what they are doing and see if there are any opportunities to collaborate with the Post. One thing that they are interested in is the complimentary use of our exhibit hall. I would like to give them 15 minutes on our agenda February 22 to make their proposal." *The EC agreed to add this to the agenda of the February meeting.*

Wolfangel reported he has a Law & Order Program nomination from Hamilton County Sheriff's Office for the Law Enforcement Officer of the Year, and he expects to receive a nomination from the Anderson Fire Department for Firefighter of the Year.

Service, Veterans Affairs / Economic / Legislative: Chair Cleves:

Bingo: Chair Sears provided the December report, included with these minutes. Additional items were:

He has submitted the fee and application for a <u>Type 3 Bingo license</u>. A separate checking account is required for Bingo.

Short reported The Lounge will start selling <u>Queen of Hearts</u> tickets on February 12. He is setting up a date for the Alcohol Server Knowledge (ASK) class.

The 2023 Fish Fry (February 24 - April 7) may be delayed or cancelled due to lack of volunteers to manage the event. The fish and the fryer oil have to be purchased in advance; the kitchen commercial refrigerator is down. Caskey will contact Porter about emailing the Fish Fry Worker signup sheet, with involvement by Sears and Minnich.

Event Coordination: Chair Knight submitted the following report:

- Hall Rentals: Tuesday East Side Republican Club; March 1 Anderson Historical Society.
- Stringer and Minnich are organizing the Valentine's Day Event.

House: Chair Alfieri provided the following report:

- The back lot light poles are to be fixed tomorrow, and he will have the light on the end of the building fixed too.
- Wolfangel suggested that we need a light above the Legion signs near the club room door.
- The commercial refrigerator needs a new compressor. After investigating the purchase of two residential refrigerators, it was agreed to repair the existing refrigerator. *Motion (Alfieri) made to have Day's Appliance Repair replace the compressor for \$1,320, Seconded (Wolfangel) and approved unanimously.*

Wolfangel reported he submitted a media release to the Enquirer regarding the Valentine's Day dance. He has a media release ready for the Fish Fry once he gets the pricing.

• Internal / Newsletter:

<u>Uniform Ceremonies:</u> SAA Caskey reported:

- The Joseph House bin is empty.
- Color Guard duty Friday at AHS, including student participation.

• Gregorio will perform the SAA duties while Caskey is out for knee surgery and recovery.

Carey reported that member Dick Peters and Winnie Clayton have taken on a project to install flags on empty flagpoles along Beechmont.

Charities, Inc. (C.I.): In his excused absence, Chair Bishop submitted the following report:

"Solicitations- CI received solicitations from Team Johnson Motors. They operate the POW*MIA Freedom Car Tour and Awareness Campaign. This year no budget funds have been allocated to support this project. However, the purpose of this project is associated with our mission, so we could divert some of our budgeted funds (\$50) from other projects. Also, should we want this line to get money in 2024, it needs to be placed in the budget."

Motion (Wolfangel) made to decline a contribution for 2023, and consider for 2024 budget, Seconded (Alfieri) and approved unanimously.
