# Fund-Raising: (Vacant)

Carey reported he and Short are investigating options for video gaming at the Post. A proposal should be distributed before next month's EC meeting.

SAL 2<sup>nd</sup> Vice Commander Sledge presented the proposal for Queen of Hearts game drawings at the Post, included with these Minutes, outlining the Overview, Objectives, Goals, and Execution Strategy for proceeding. After discussion, *Motion (Wolfangel) made to accept and approve the proposal, use of the hall to be at no rental charge, with determination and adjustments to start date; times, dates and frequency of* 

drawings; operation of concession/bar; and other details of operation to be determined by the appropriate officers and chairs of the Post and SAL, Seconded (Minnich) and approved unanimously by the EC. Motion (Bishop) made to permit employees of The Lounge to sell the game tickets during the event at the Post, Seconded (Minnich) and approved unanimously by the EC.

#### **Event Coordination**: Chair Ken Knight submitted the following report:

Hall rentals are committed for March and June. Monthly rental to East Side Republican Club is probable.

Knight reported receiving a request from US Census Bureau to use the Hall for employee training gratis. *Motion (Alfieri) made to decline the request, Seconded (Caskey) and approved unanimously.* 

## **House:** Chair Alfieri provided the following report:

- The House has been operating very nicely.
- Oven cleaning, refrigerator cleaning, and general kitchen cleaning are being done by Tammy McCauley.
- Future projects: painting the interior of the club room and Hall.
- The remaining 2 toilet replacements are to be done by New Year's Eve; all are working properly.
- Alfieri will check with Tammy regarding food sales at events in the Hall.

## **SAL Unit:**

#### SAL Commander Short reported:

• He will notify SECO to reset the security system after the New Year's Eve bash.

• The Ohio Department of Public Safety offers a class, "Alcohol Server Knowledge" (ASK), for the Post and the Squadron to provide information and answer questions relative to liquor licensing, laws and regulations, bartending, sales and consumption issues. *The EC will provide Short with a date for scheduling the class.* 

Stuntz confirmed the Post is adequately stocked with beverages for the New Year's Eve bash.

Wolfangel reviewed the following SAL issues:

- 1) Commander Short is obtaining three more signatures on the Charter document.
- 2) Short is working with Lindsey on the collection of the remaining \$29 from each member that has not yet paid the full \$40 dues to Squadron.

- \* Need to be presented and adopted by SAL 318 Membership and attested to by SAL 318 Adjutant signature.
