Carey noted receipt of the Annual Post Data Report, Consolidated Post Report, Certification of Post Officers, Post Chairman Certification; he called for input from other officers to complete the reports when requested.

BUDGET REPORT / FINANCE ISSUES AND CONCERNS: Finance Officer Lindsey submitted the Finance Report as of March 29, 2023, a copy of which is included with these E.C. Meeting Minutes, in E.C. Minutes binder in Post Club Room for individual review, or may be provided upon individual request.

- The finances remain in good shape; all bills are paid.

Bishop noted the meeting with First Financial Bank regarding facility mortgage payoff and refinancing options is being scheduled for the next week or two.

NEW ISSUES / NEW BUSINESS (Commander):

Porter reported the Post received a Health Department inspection during the March 17 Fish Fry, with recommendations provided regarding hand- and dish-washing and cooked food temperature; however, we passed the inspection.

Commander Stegmann recommended the Post pro-actively offer assistance and support for disabled veterans in our area; Cleves will prepare a newsletter article.

NEW ISSUES / NEW BUSINESS (Polling of Committee Chairs):

Membership: Chair Kamman reported:

• We are down 15 members from our quota.

Americanism: In the excused absence of Chair Howland, Carey provided the following report submitted:

"BGS applications and final check have been submitted.

BBS applications have been received from 2 boys. The third is currently absent from school and not communicating with the school or me. The AHS Vice-principal is tracking him down to get his application.

Scholarships are out at all three local HS's. None returned yet."

Bishop reported the Chamber of Commerce recognized the work and volunteers at Hillcrest cemetery over the years.

Bishop reported a "Save a Warrior" presentation will be scheduled for the April EC meeting.

Service, Veterans Affairs / Economic / Legislative: Chair Cleves:

<u>Bingo:</u> Chair Sears submitted the March 2023 report, and made the following additional comments:

- Bingo will not be conducted Easter Sunday, so there will be only 4 Bingo Sundays in April.
- Bingo workers need volunteers to train in their duties, so the games can continue in event of illness or incapacitation.

Fund-Raising: (Vacant)

- Fish Fry:
 - o Bishop presented a Year-to-Date summary report of stats and financials.
 - o Kamman noted the SQUARE fee is not refunded on credits.
 - o Comments made by Carey regarding the inconsistent application of the charge for meals for volunteers will be forwarded to Porter and Franz.
- <u>Karaoke</u>: Wolfangel reported Karaoke is authorized through March, and he sought authorization from the EC to conduct Karaoke through June 8. *Motion (Stuntz) to provide such authorization through June 8, Seconded (Kamman) and approved unanimously*.

Event Coordination: Chair Knight reported:

- Hall Rentals: No more rentals in March; one in April
- The Armory safe has a cash drawer for use during hall rental activities and an 8x11 envelope containing \$150 marked "Hall Rental" placed under the cash drawer; the money has been taken. Previously, \$55 was also missing from the envelope.
- Knight will get a price for a separate safe designated for Hall Rental use.

Bishop will see if access cards can be in 3 levels instead of the present 2 levels.

House: In the excused absence of Chair Alfieri, the following was discussed:

Regarding the easement allowing cross-parking in the rear of the property, Bishop pointed out that all parties to the existing easement agreement must be party to any subsequent agreement with Anderson Land Holdings.

- External: <u>Cinco de Mayo Dance</u>: Wolfangel has prepared a media release which will be submitted in the next week or so.
- **Internal / Newsletter**: Gregorio reported the April newsletter was finalized today, will be forwarded to Minnich, and hard copies will be mailed to 18 recipients April 1 or 2.

Uniform Ceremonies: In the excused absence of SAA Caskey, Assistant SAA Gregorio reported:

Caskey has ordered 15 white parade gloves and 15 white pistol belts for the Color Guard Memorial Day Ceremony. He spoke with Tammy regarding providing the breakfast at the Post. Color Guard volunteers will be sought in April.

He made a Joseph House delivery in March.

<u>Charities, Inc. (C.I.):</u> Chair Bishop reported:

• Poppy Day May 26; he is short 1,200 poppies to have 4,000 to 6,000 on hand. He gave up on Kroger hosting the event, and is seeking other locations willing to host.

Good of Legion:

Wolfangel provided a report from the Club Room Revitalization Committee (CRRC), included with these Minutes, and to be included in the newsletter. He requested authorization by the EC for and expenditure of up to \$3,800 for the following:

- 4 to 5 high-top square tables with four matching chairs each for area to be vacated by Pool Table disposal.
- Up to 8 replacement Bar Stools.
- Dual ceiling lighting system, converting existing Club Room fluorescent to LED, and adding recessed LED lights.
- Back-lighted stained glass wall art (US flag with Eagle head)

Motion (Cleves) to authorize up to \$3,800 covering the above items, Seconded (Dubois), approved unanimously.

Wolfangel noted that the E.C. members at previous Post Meeting authorized an expenditure of up to \$750 for 10 3' X 3' card tables for move of Euchre events from Club Room to rental Hall.

Wolfangel noted the ATM machine is installed, loaded, and operational.

Comments from Carey from his "Return to Vietnam" trip March 1-10, 2023:

• From Defense POW/MIA Accounting Agency: 1,240 MIA in Vietnam, 500 reasonable locations for recovering remains. Not including Laos and Cambodia. All POW are recovered or deceased.

• Lingering memories of the Legion not recognizing Vietnam Vets.
