MINUTES OF LAST MEETING:

Adjutant Carey noted that the E.C. Meeting Minutes from June 28, 2023 were posted in E.C. Minutes Binder in club room, distributed to all E.C. members, and sent to Post Web-Master for posting on Post web-site. *Motion*

(Wolfangel) made to accept and approve the Minutes as submitted, Seconded (Bishop), and passed by unanimous vote of E.C.

POST EVENT CALENDAR REVIEW:

2nd Vice Commander Minnich reported all currently scheduled Post activities and events are updated and on the calendar.

<u>CORRESPONDENCE LOG</u>: Adjutant Carey advised and commented on action taken on following items of correspondence since last meeting:

Incoming Correspondence:

- Routine bank statements, ads, magazines, dues payments, invoices, etc.
- Invitation to Henry Klein returned to sender. *Forwarded to Wolfangel*
- Solicitation for donations to Chained Eagles of Ohio. *Forwarded to Bishop*
- Solicitation for goat buyers at Clermont County Fair from 11-year-old Aiden Gilbert. *Posted on BB*
- Second request from Ohio Liquor Control for additional information to renew liquor license. *Forwarded to Stuntz*
- Voicemail asking for permission to put a sign on Patriot Center property to vote yes on Issue 1. *Response provided by Wolfangel*
- Check for \$100 from Anderson Township for the Most Patriotic Unit in the July 4 parade. *Given to Lindsey*
- Donation acknowledgment from USO for \$100. Posted on BB
- Acuity Insurance renewal notice due September 22. Forwarded to Lindsey
- Email from HopeCheck offering their email system of implementing a buddy check for \$19/month. *Discussed below*

Misc. Adjutant Items:

Carey outlined his plan to reorganize the office file drawer with individual names on them; the flat drawers above and the SAL drawer will continue as presently used.

BUDGET REPORT / FINANCE ISSUES AND CONCERNS: Lindsey submitted his report for July 26, 2023, included with these minutes; he further reported that all bills are paid, and the Post is solvent.

The Acuity notice included above in the incoming correspondence regarded terrorism coverage of the facility. The annual premium for the terrorism coverage would be \$37,000 or higher, depending upon the value of the property. Our past practice has been to decline the terrorism coverage. *Motion (Wolfangel) made to decline terrorism insurance coverage of the property, Seconded (Bishop) and approved unanimously by the EC.*

Status of the mortgage pay-off:

At the June 12 meeting of the EC, it was voted to pay off the property mortgage with a payment of approximately \$142,000. Subsequently, Lindsey provided additional information regarding our cash flow. *Motion (Wolfangel) made to vacate the EC decision of June 12, 2023 to pay off the mortgage, Seconded (Alfieri) and approved by the EC, with one opposed.* Additional discussion followed. Alfieri described the deteriorating condition of the building, the rooftop condensers, and the parking lot, indicating significant funds will be needed eventually to address those items. Bishop provided an analysis of the trend of total available funds over the past five months. Following extensive discussion, *the EC voted by show of hands to continue with the existing loan, which*

requires a final (balloon) payment of approximately \$81,722 at the end of September 2028, by a vote of 12 for and one opposed.

OPEN ISSUES / OLD BUSINESS:

Wolfangel provided an update on the Club Room Revitalization Committee, as follows:

- Three Hi-top tables and chairs received and have been assembled, and are awaiting placement upon completion of CR construction projects by SAL.
- Six swivel bar stools received and in use.
- Painting of CR walls completed.
- Installation of corrugated steel on lower portion of walls is in progress by SAL.
- Replacement for existing CR TV and installation of two additional TVs for CR pending by SAL.
- Secondary can light system pending installation (by Chris Short).
- Once all above completed will return select wall hang items to CR for display, with some other still being moved to lobby.

Stegmann requested an estimated completion date for the club room work.

Wolfangel provided the following update on the MEMORIAL PLAQUE EXPEDITURE FOR DESIGNATION OF "HALL A" AS HUGO VONTZ, JR. MEMORIAL HALL.

- Plaques for both Hall A and Hall B as approved at 6/28/23 E.C. Meeting, Obtained and in place over the double door sets to the respective halls.
- Total Cost \$20.50

Wolfangel provided the following update on replacing the large Patriot Center roof top sign:

- Design and Cost Quote of \$1,400 installed for replacement of Roof Top Sign.
- The EC viewed two options for the new sign: blue background or white background. *Motion (Alfieri) to proceed with the white background, Seconded (Kamman) and approved unanimously.*

Wolfangel updated the possible installation of electronic gaming machine in the club room:

- Grover Gaming: Notified contact that we would be waiting until CR project completion for scheduling any meeting or demo of offered equipment. Anticipate inviting to pre-August E.C. Meeting for demo / discussion.
- Minnich has had preliminary discussion with Arrow.
- Our type 3 license would need to be amended.

Stegmann presented the following information he received:

- He requested comments on the disposition of past VHP certificates and Ohio state flags. It was agreed to donate one of the flags to Bobby Musselman.
