# MINUTES AMERICAN LEGION POST 318 REGULAR MEETING December 14, 2022

(NOTE: This Meeting was conducted physically at Post 318, with none in attendance via ZOOM.)

Due to the excused absence of Commander Stegmann, the Post Meeting was called to order by Post 1<sup>st</sup> Vice Commander Kamman, at approximately 7:00 PM. Colors were in place and saluted. 1<sup>st</sup> Vice Commander Kamman gave the Recognition and Placement of POW-MIAs, and the POW-MIA Chair Cover was placed by Surdick. The Opening Prayer was given by Chaplain Heberly. Reciting of the Pledge of Allegiance was led by 1<sup>st</sup> Vice Commander Kamman. Reciting of the Preamble was led by 2nd Vice Commander Minnich. 1<sup>st</sup> Vice Commander Kamman then opened the meeting for the normal order of business.

<u>Minutes:</u> Adjutant Carey noted that the Post Meeting Minutes from the November 9, 2022, meeting were posted in Post Meeting Minutes Binder in club room, distributed to all E.C. members, and sent to Post Web-Master for posting on Post web-site. *Motion made (Bishop) to accept the November 9, 2022 Minutes. Motion was Seconded (Stuntz), and approved unanimously.* 

Executive Committee Notes: Adjutant Carey advised that the November 30, 2022 E.C. Meeting Minutes, in full printed format, had been placed in the E.C. Meeting Minutes binder in the clubroom bookcase, and distributed to all E.C. members, and have been submitted for posting on Post web-site. A summary of noteworthy items or actions from the E.C. Meeting were reported as follows:

- Agreed unanimously to leave the initial SAL charter fees of \$210 with SAL.
- Agreed unanimously to permit the family of member Lee Bobitz to present him with a Quilt of Honor during the Post Christmas Party.
- Agreed with one opposed to <u>tentatively</u> approve the rental of the Hall for the drawings associated with the Queen of Hearts game conducted at and by The Lounge, such rental of the Hall beginning in February to be at no charge, pending <u>final</u> decision by the EC upon receipt of a formal proposal from SAL 2<sup>nd</sup> Vice Commander Todd Sledge, owner of The Lounge.
- Agreed with one opposed to leave new Sections 4-7 (enumerating the responsibilities and duties of four EC positions) out of Article VIII of the Draft Post By-Laws.
- Agreed unanimously to leave new Section 4 (regarding the consumption of alcoholic beverages at Legion meetings) out of Article X of the Draft Post By-Laws.
- Agreed unanimously to accept all changes to the Post Constitution and By-Laws approved by the EC and submit the revised Post Constitution and By-Laws for ratification at the January General Meeting.

## **Finance Report:**

Finance Officer Lindsey presented a written Post Financial Report, as of November 30, 2022, copy included with these Minutes, provided copies to members in attendance at this meeting, and noted all known bills are currently paid. His additional remarks were:

- The Post facility insurance premium has been paid for the year.
- The mortgage balance is approximately \$150,000.
- The Post needs more fund-raising; Hall rentals and Bingo income is trending down.
- He seeks a replacement as Finance Officer due to his new full-time workload.

Motion made (Wolfangel) to accept the November 30, 2022, Finance Report, subject to audit. Motion was Seconded (Bishop), and approved unanimously.

Constitution and By-Laws Revisions and Updating: Post Executive Committee, over the past several months, have reviewed necessary and recommended revisions to the Post 318 Constitution and By-Laws, to reflect the current operational processes and procedures of the Post, as well as to reflect the formation of the Post 318 "Sons of the American Legion Squadron 318." At their November 30th E.C. Meeting, the E.C. by unanimous vote approved the recommended changes, with a recommendation that they be presented to the membership to be ratified at the January 11th Post General Membership Meeting. In accordance with the provisions of both the Post Constitution, and the Post By-Laws, a notice will be sent out the Post membership not later than later than December 31, 2022, advising of access to the "Revised and Updated" Constitution and By-Laws either via electronic copy or physical review in Post club room, and giving notice of ratification vote at January 11, 2023 Post Meeting.

#### • New Business:

Gregorio reported blank M1 cartridges that have 5 crimps, rather than the current design of 6 crimps, must be properly disposed of, due to possibility of explosion. Wolfangel noted the Sheriff's Department will dispose of it.

Military / Legion Magazine Back Issues: As most of you who frequent the Post club room should be aware we subscribe to four (4) monthly military magazines (Army times / Navy Times / Air Force

Times and Marine Times) of which we maintain the most recent three copies on the book rack (in folders) near the Dart Board, and while we encourage you to make use of them, we ask that you not remove them from the club room during that period so all can have access. After that three month period Bob Alfieri always delivered the oldest months publications to Mercy Hospital for use of their patients. However, since COVID, they no longer accept them. We have now been placing these older publications in a plastic basket on the club room display for the personal taking by any Post members. We are also doing the same with the older copies of the Legion magazines that we also receive, although most of our members probably receive them at home also. These older issues of publications will continue to be available in this manner unless the hospitals start accepting them again or we dispose of them.
