MINUTES AMERICAN LEGION POST 318 REGULAR MEETING March 8, 2023

<u>Minutes:</u> Ass't Adjutant Wolfangel noted that the due to lack of a quorum at last meeting, the acceptance and approval of the January 11, 2023 Minutes was postponed until this meeting, at which we also have the meeting Minutes from the February 8, 2023 meeting Minutes, both of which have been posted in Post Meeting Minutes Binder in club room, distributed to all E.C. members, and submitted for posting on Post web-site. *Motion (Don Bishop) to accept and approve both sets of Minutes was seconded (Steve Stuntz), and passed unanimously*.

Executive Committee Notes: Ass't Adjutant Wolfangel advised that the February 22, 2023 E.C. Meeting Minutes, in full printed format, had been placed in the E.C. Meeting Minutes binder in the club room, and distributed to all E.C. members, and have been submitted for posting on Post web-site. A summary of noteworthy items or actions from the E.C. Meeting were reported as follows:

- Were advised by Finance Officer Lindsey that he was attempting to set up meeting with First National Bank to determine and plan for Post options available at Post Mortgage renewal which comes due in September. Lindsey also reminded that he plans to step down from his position at end of term in June, and needs someone to learn the F.O. duties / responsibilities.
- Were advised currently have 3 boys and 2 girl selected for BBGS. Bishop advised we have sufficient funds to send a total of 7,(boys or girls).
- Received summary s report from the Wolfangel on Club Room Revitalization Committee's (CRRC) first meeting, and approved the Pool Table disposal proposal recommended by CRRC, and added to it their approval for disposal of the piano in lobby.
- Approved installation of an ATM in lobby, through Pioneer Vending, as presented and recommended by CRRC.
- Approved request from Bishop for securing of an additional 25 Security Access Cards, mostly due to increasing SAL membership.
- Noted need for Commander to appoint Nomination Committee at March Post Meeting.
- Set date for Post Awards and Recognition Program for July 22, 2023 at 7 PM.

Finance Report:

<u>Club Room Revitalization Committee (CRRC):</u> Wolfangel gave a summary report on recent meeting. He also suggested that since there was a quorum of E.C. members present at this, he would like to present an interim proposal to E.C. members in attendance, as opposed to waiting until E.C. meeting, to expedite several of the committee's proposals, which were as follows:

- 1) Securing 4 hi-top tables w/chairs to go where pool table was previously located.
- 2) Securing 8 new bar stools to replace current ones.
- 3) Securing 10 3' X 3' folding card tables for use of Euchre when moved to rental hall space.
- 4) Supplies for stain glass light wall art project.
- 5) Replacement of CR ceiling lights with dimmable recessed lights.

All of these items were recommended to be done at Post expense since the Post is responsible for the upkeep of the Club room. SAL had indicated they were willing to over costs related to painting and installing new wall coverings from chair rail down. It was felt if Post cost limits proposed were approved a search could begin to obtain the best products available, for the least amount of cost, not to exceed the requested amounts. The total amount for all projects proposed was not to exceed \$4,150.

Following considerable discussion, a Motion (Bob Kamman) was made to approve up to \$750 for the new Euchre tables. Motion was seconded (Bob Alfieri), and passed by majority vote of E.C. Balance of items will be addressed at regular E.C. Meeting.

<u>Post Website:</u> Kamman and Minnich commented on changes made to Post Website, which is no longer being handled by former webmaster - Josh Richardson. The changes include a SAL page.
